<b>QUALIFICATION REQUIREMENTS</b>	<p>A) One year of experience in graphic arts or design work and graduation from high school; or</p> <p>B) Any equivalent combination of experience and training which provides the minimum knowledge, abilities and skills.</p>	
<b>NATURE OF WORK</b>	<p>This is routine technical work involving the preparation of a variety of graphic arts projects. Employees in this class perform routine technical work in graphic arts independently after initial training and work under closer supervision on a variety of more complex developmental assignments.</p>	
<b>ILLUSTRATIVE EXAMPLE OF WORK</b>	<p>Produces routine illustrations, mechanical or freehand lettering layouts, designs, and formats for appropriate visual aide materials. Analyzes copy and prepares layouts of office forms for departmental use. Visualizes concepts for preparation through multi-media materials including television. Performs related duties as required.</p>	
<b>KNOWLEDGE, ABILITIES &amp; SKILLS</b>	<p>Knowledge of the principles and techniques of illustration and perspective design, color harmony and composition. Ability to create concept and artwork for a variety of visual aide materials for effective communication. Ability to visualize ideas on paper. Ability to design forms, graphs, and charts. Ability to work effectively with the public and employees. Ability to communicate effectively, orally and in writing. Skill in the use of tools utilized in illustration, layout and design work.</p>	
<b>MINIMUM EDUCATIONAL REQUIREMENTS</b>	<p>All new employees (defined as excluding current government of Guam employees, or former government of Guam who are eligible for re-employment or reappointment), shall be required to have a high school diploma or equivalent as allowed by Public Law 29-113 when applying for a position, with the exception of those positions listed on the list approved by Attorney General.</p>	
<b>DOCUMENTATION REQUIREMENTS</b>	<p>Applicants claiming educational accomplishments are required to submit official or verified copies of transcripts or diplomas. The diploma, degree, or credits required must come from an education institution that is accredited or recognized by either its government or a government recognized accrediting agency. This applies to all new employment after October 1, 2008 pursuant to Public Law 29-113. If you wish to claim for any preference points, please read the employment application General instruction page for additional information. <b>PROHIBITION PURSUANT TO P.L. 28-98</b>	<p>No person convicted of a sex offense under the provisions of Chapter 25 of Title 9 GCA, or an offense as defined in Article 2 of Chapter 28, Title 9 GCA in Guam, or an offense in any jurisdiction which includes, at a minimum, all of the elements of said offenses, or who is listed on the Sex Offender Registry shall work in any agency or instrumentality of the government of Guam.</p>	

<b>EXAMINATION REQUIREMENTS</b>	A written test is not required. Applicants will be rated on a scale between 70.00 and 100.00 percent on the basis of training, education and experience in relation to the minimum requirements of the position.
<b>INTERVIEWING PROCEDURES</b>	A personal interview or interview by telephone (if off-island) will be held by the Office for all eligible's referred via certification.
<b>EMPLOYMENT MEDICAL EXAMINATION</b>	All applicants accepting employment must undergo a medical examination and be declared by a physician as capable of performing the duties of the position being hired for.
<b>WORK ELIGIBILITY</b>	When offered a position, you will be required to provide proof of identity and eligibility for employment in the United States as a condition of employment.
<b>DRUG SCREENING</b>	Applicants selected for an offered employment with the Government of Guam shall undergo and pass a mandatory drug test before being employed. This also applies to employees selected for Testing Designated Position (TDP). Failure to submit or pass such drug test shall be grounds for rescinding the offer of appointment.
<b>VETERAN'S PREFERENCE</b>	Applicants claiming veteran's preference are required to provide a copy of their DD-214 (military discharge form). Those claiming compensable disability are required to provide a copy of a letter from the Veteran's Administration.
<b>WHERE TO APPLY</b>	Submit job applications in person or by mail to the Office of the Attorney General, 590 S.
